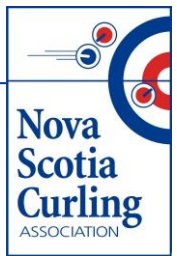
	<p>Virginia shared her view that NSCA should communicate with teams participating in qualifying tournaments that lead to national championships in advance of them entering to make them aware of additional requirements associated with travelling to national tournaments.</p> <p>Discussion took place around how and when best to do this. It was suggested that all teams participating in qualifying in 2019-20 be polled to determine their interest/ability to participate in national qualifying bonspiels in 2021.</p> <p>Chris asked directors to give it some thought and share their position with Andrew and Virginia.</p> <p>Virginia advised that NSCA will receive \$3,468 in federal funding. In addition, 5 of the 7 clubs who applied in September will receive between \$1,000 and \$3,000 each. NSCA will distribute this funding. Clubs are reminded of the December 15th deadline to submit applications to Virginia for the next round of funding.</p> <p>A number of banners celebrating last year's achievements still need to be distributed and if directors can help please let Virginia know.</p> <p>Virginia reported that the NSCA has been pleased with updating of website completed by Dustin Mikush to date. It is recommended that his contract be extended until end of March 2021.</p> <p>MOTION: To extend contract with Dustin Mikush to provide 5 hours of website maintenance a week for 20 weeks at an hourly rate of \$19 – a total of \$1,900.</p>		<p><i>Banners will continue to be presented to winning teams.</i></p>

Mosher asked if there were any questions related to the report. No questions were raised.</p> <p>NSCA has negotiated streaming of the provincial Scotties and Tankard with SaltWire. NSCA will pay \$6,000 to have three days at each event livestreamed and SaltWire will provide \$6,000 of media promotion for our events. They are also working to get other sponsors involved which has the potential of reducing cost to NSCA.</p> <p>A number of clubs still need to submit their COVID response form to NSCA. Board members will reach out to clubs in their region to prompt them to send them in.</p> <p>Virginia reminded directors of the process related to obtaining affiliation fees from member clubs including the need to have clubs send member data (gender, Year of Birth and postal code) to NSCA by December 1, 2020.</p> <p>An update to committee participation was provided and circulated by V. Jackson. Chris shared that COVID and operations have taken a lot of time over the last number of months and is looking for help from directors to move association forward through committee activity.</p>
